- 1. Appointment of Don Henniger to complete Rebeca's Member-at-Large Term
  - a. M/S/C to appoint Don Henniger to the unexpired portion of Rebeca Fassett's term. (Xenia/Gudrun) Ayes: 6, Nays: 0, Abstentions: 0
- 2. Proposal from Ad Hoc Aesthetics Team Aesthetics Ministry, Celia Ortenberg
  - a. A written proposal was submitted in advance of the board meeting.
